GENERAL TERMS AND CONDITIONS

Keli Network Inc. dba Jellysmack and its affiliates ("Jellysmack" or "we") provides The Creative Academy website at www.the-creative-academyy.com (the "The Creative Academy Site") to all visitors to the Site ("Visitor" or "you" or "Customer") subject to the following terms and conditions (the "Terms"). By accessing, using, and/or purchasing the training courses provided on The Creative Academy Site, you agree to these Terms. We may periodically change the Terms at our sole discretion without prior notice to you, so please check back from time to time. For an explanation of Jellysmack's practices and policies related to the collection, use, and storage of the The Creative Academy Site visitors' information, please read our <u>Privacy Policy</u>.

Conditioned upon your acceptance of these Terms, Jellysmack hereby grants you permission to access and use The Creative Academy Site as set forth in these Terms. If you do not agree with these Terms, do not use The Creative Academy Site.

LEGAL CAPACITY

The Customer declares that you have the full legal capacity to commit to the terms, conditions, obligations, affirmations, representations, and warranties set forth herein, and to abide by and comply with these Terms. Should you access and/or use The Creative Academy Site and/or purchase Training Courses (as defined below) on behalf of another legal entity, you hereby represent and warrant that you have the legal authority, actual or implied, to bind that entity to these Terms. Any order or purchase of an online training course from Jellysmack, which results in the establishment of personalized accesses to the Educational Platform(as defined below), assumes that the Customer acknowledges having read these Terms, having understood them and accepted them with full knowledge of the facts contained therein.

Online Training Courses

Jellysmack reserves the right to modify the price and the content of its Training Courses at any time, informing Customers as such by updating the page relating to the Training Course concerned, as well as in the catalog and/or via Discord.

Supervision

Supervision is a privileged time between the Customer and one of The Creative Academy's experts, (the "Trainer"). These sessions aim to consolidate your knowledge and learning. Run as individual sessions, they are geared towards answering the questions and responding to the needs of each specific Customer. In addition to the sessions already scheduled during the Training Course, additional sessions can be booked via a direct message sent to the Trainers on Discord.

REGISTRATION FOR TRAINING COURSES

Jellysmack shall present a webinar detailing the Training Course, including information about the Training Course and modules .

The prices of Training Courses are provided net, in USD, exclusive of taxes. You may pay the full amount owed in one (1), six (6) or ten (10) installments, with no additional fees or charges.

RETURN POLICY

If you are not happy with your purchase, you may request a refund within seven (7) days and Jellysmack shall refund the fees paid for the Training Courses.
